Investment Strategy

The investment objective of the Berenberg Aktien Deutschland Fund is long-term capital growth, which should exceed the performance of the benchmark HDAX over a medium to long-term period. The main driver for this is the above-average profit growth of the selected companies. The strategy is based on a disciplined bottom-up stock selection of attractive standard as well as small and mid caps domiciled in Germany or listed on the German stock exchange.

- Predominantly growth-oriented funds
- Diversified portfolio of 40-60 stocks
- Investment level can be controlled flexibly (usually 90-130%)
- Admixture of small and mid caps (usually 40%)
- Active approach, i.e. index weights have no influence on individual stock selection

Fund management comment

The GDP growth in Germany was surprisingly positive compared to the previous quarter, with construction investment and exports making a positive contribution to growth for the first time. However, the Berenberg Aktien Deutschland performed negatively compared to its benchmark in May. The Sartorius share disappointed the market due to weak demand for equipment and low visibility for a recovery. After Sixt published a profit warning, the share price fell by double digits. Adesso shares weakened due to higher investments in IT solutions, no sales contribution from the high-margin licence business and lower capacity utilisation. In contrast, Siemens Energy shares pleased investors thanks to the strong quarterly figures, which were well above analysts' estimates. The prospect of further share buybacks through the sale of the US entertainment business supported Allianz shares. Münchener Rück shares also performed well after a strong first quarter. Last month, we increased our position in Nemetschek and reduced our positions in Siemens and Deutsche Telekom.





Consideration of ESG Elements

Identifying companies and business models that will be successful in the long term is the basis for good investment decisions. Environmental, Social and Governance (ESG) factors are key factors in decision making and are therefore integral components of the investment process.


CO₂ Intensity

The fund does not actively manage its carbon footprint, however, emissions data such as CO2 intensity are relevant parameters which can be used to assess the efficient management of a company and the extent of transition risks.




ESG Score

The data provider MSCI ESG uses an ESG score of 0 to 10 to assess the management of material ESG risks of portfolio holdings compared to competitors.



ESG Controversies Screen

Investments in the fund are monitored for ESG controversies and, with the help of MSCI ESG data, flagged according their severity. Thereby, potential ESG risks of investments are identified. In the case of an orange flag (severe controversy), we enter into an active exchange with the company. In the case of a red flag (very severe controversy), the company is excluded.

Glossary & Methodology

Active Ownership

The term "Active Ownership" encompasses all our activities where we, as an investor, attempt to positively influence a company's management of ESG aspects. This includes Engagement, i.e. direct dialogue with companies to discuss specific ESG objectives as well as proxy voting, i.e. our voting recommendations to our fund administrator, which then exercises the voting rights at general meetings.

CO₂ Intensity

The CO2 Intensity (Scope 1 & 2 emissions) per company is multiplied by is portfolio weight (current value of the investment by current portfolio value) and summed up. This weighted average CO2 Intensity provides an indication of the portfolio's exposure to CO2-emission intensive companies.

ESG Score

Using a score between 0 (lowest) and 10 (highest), MSCI ESG assesses the ability of portfolio holdings to identify and manage environmental, social and governance-related risks compared to peers. The ESG scores are assigned at the holding level and are aggregated at the portfolio level as the weighted average ESG Score.

ESG Controversies Screen MSCI ESG analyses controversial

MSCI ESG analyses controversial business practices from the five areas environment, human rights, labour rights & supply management, customers and governance. The controversies are rated according to their reputational risk as well as the operational handling by a flagging system. Green indicates no or weak controversies, yellow indicates moderate controversies, orange indicates severe controversies and red indicates very severe controversies.
